

“JACK DANIEL'S IBA INDIAN FTRS PROMOTION”

TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is Brown-Forman Australia Pty Ltd (ABN 87 000 064 086) of Level 6, 280 Elizabeth Street, Surry Hills NSW 2010. Telephone: (02) 9764 8777.
3. Entry is only open to Australian residents aged 18 years or over. Employees (and their immediate families) of the Promoter, Participating Outlets (as defined below) and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. A participating store is any The Bottle-O, Big Bargain, IGA Liquor, Ritchies or Cellarbrations store nationally that displays advertising materials for this promotion (each a “**Participating Outlet**”).
5. Entries into the promotion open and close on the following dates depending on the Participating Outlet:
 - Cellarbrations: opens 02/08/2021 and closes at 11:59PM AEST on 29/08/2021.
 - The Bottle-O & Big Bargain: opens 09/08/2021 and closes at 11:59PM AEST on 05/09/2021;
 - IGA Liquor: opens 11/08/2021 and closes at 11:59PM AEST on 07/09/2021; and
 - Ritchies: opens 11/08/2021 and closes at 11:59PM AEST on 14/09/2021(each a “**Promotional Period**”).
6. To be eligible to enter, individuals must spend \$20 or more on any Jack Daniel's product at a Participating Outlet during the relevant Promotional Period (“**Qualifying Transaction**”). Individuals must also ensure they obtain a purchase receipt for their Qualifying Transaction. In the event a receipt is not automatically handed to them, it is the individual's responsibility to request one.
7. To enter, individuals must then, during the applicable Promotional Period, visit <http://www.jackspromo.com.au/IBA-Indian> follow the prompts to the promotion entry page, input the requested details (including their full name, address, email address, phone number and date of birth), upload a copy of their purchase receipt when prompted and then submit the fully completed online entry form.
8. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

9. Incomplete or indecipherable entries will be deemed invalid.
10. Multiple entries permitted, subject to the following: (a) only one (1) entry permitted per Qualifying Transaction (regardless of the amount spent in excess of \$20 on Jack Daniel's products in that transaction); (b) each entry must be submitted separately and in accordance with entry requirements; (c) a maximum of one (1) prize is permitted per person (excluding SA residents); and (d) there is a limit of (2) entries per person per day.
11. Entrants must retain their purchase receipt(s) for all entries as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an entrant's entries and forfeiture of any right to a prize. Purchase receipt(s) must clearly specify the store of purchase, that \$30 or more was spent on Jack Daniel's products and that the purchase was made during the relevant Promotional Period but prior to entry.
12. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
13. The draw will take place at Anisimoff Legal, Suite 5, Erina Plaza, 210 Central Coast Highway, Erina NSW 2250 on 17/09/2021 at 3:00pm AEST in the presence of an independent scrutineer. Additional reserve entries may be drawn and recorded in order in case an invalid entry or ineligible entrant is drawn. Winners will be notified in writing within two (2) business days of the draw and their names will be published online at <http://www.jackspromo.com.au/IBA-Indian> from 20/09/2021.
14. The Promoter's decision is final and no correspondence will be entered into.
15. The first valid entry drawn will win the major prize of a 2021 Indian Motorcycle FTR S in White Smoke colour and \$1000 worth of Indian accessories (to be determined by the Promoter in its absolute discretion). Total prize value is up to \$23,995, including registration, compulsory third party insurance, stamp duty and dealer delivery charges (which may vary State by State).
